Criminal History Statement

(attached to Personal/Criminal History Statement of Ming, Charles Ka Fook)

1. On September 29, 1980, the Government of Hong Kong laid two charges against me, being,

1st Charge : Offering an advantage, contrary to Section 4(1)(a) of the Prevention of Bribery Ordinance, Cap.201, Laws of Hong Kong

2nd Charge: Offering an advantage, contrary to Section 8(1) of the Prevention of Bribery Ordinance, Caop.201, Laws of Hong Kong

- 2. The case alleged against me under the 1st Charge was that I had, on or about December 20, 1979, without lawful authority or reasonable excuse, offered an advantage, namely, an all expenses paid vacation to the United States of America, to a Mr. Edward Trevor Kennard, a public servant, as an inducement to or reward for or otherwise on account of Mr. Kennard having performed an act in his capacity as a public servant, by the giving of advice in relation to the development of a building site situated in Hong Kong.
- 3. The case alleged against me under the 2nd Charge was that I had, on or about January 23, 1980, in Hong Kong, being a person having dealings with the Government through the Public Works Department without lawful authority or reasonable excuse, offered an advantage, namely, the supply of complimentary ferry passages to Macau and hotel accommodation in Macau to a Mr. Anthony Brian Lawrence.
- 4. At the dates mentioned in the Charges, both Mr. Kennard and Mr. Lawrence were public servants employed in the Public Works Department of the Hong Kong Government.
- 5. At all material times, I am a professional architect. Before I started my own practice in 1974, I had worked in the Public Works Department for 2 years. Mr. Kennard and Mr. Lawrence were my colleagues at the time.

6. I pleaded not guilty to both Charges.

- 7. The case was heard in the District Court of Hong Kong (Victoria District Case No. 221 of 1980).
- 8. At the commencement of the trial on January 19, 1981, the Prosecution offered a nolle prosequi in respect of the 2nd Charge and the hearing proceeded against me on the 1st Charge only.
- 9. Although I was found guilty and convicted by the District Judge, on appeal, the Court of appeal quashed the conviction and set aside the sentence.
