Pursuant to your request a polygraph examination was given to the above named individual on October 26, 2005. The Backster Zone Comparison technique and calibrated four-channel Lafayette computerized instrument were used.

The purpose of the examination was to determine if you have been truthful about an assault against you by your son David, in 1994?

Based on the physiological responses produced by the subject on two polygraph charts, in the opinion of this examiner the subject <u>was not</u> attempting deception when she answered "NO" to the following relevant questions.

- 43. Did you lie to me when you said your son David assaulted you?
- 44. Did you lie to me about being assaulted by your son in 1994?
- 45. Did you lie to me when you said you were not having a diabetic reaction when your son assaulted you in 1994?

Prior to the instrumentation phase of the examination all the questions were a matter of discussion with the client to ensure clarity and a common meaning.

Question 43: +4 (No deception indicated)

Question 44: +3 (No deception indicated)

Question 45: +3 (No deception indicated)

I did not find any physical or emotional condition which would preclude a valid result during the pre-test interview.

He said he wanted to make some phones calls and went into his father's office. She followed him in and hung the phone up on him. He got angry and pushed her down by swinging his arm striking her and knocking her to the floor. She got up and said she was calling 911. She left the office and parked down the street. She said he called his dad and told him he had hit his mother. She waited a short time and waived down another family member that was coming to work.
