Dear Friend,

Over the years I have always stood to protect our Second Amendment rights. *Today I am seriously concerned that these rights are being threatened.*

As I write this letter, Seattle Mayor Greg Nickels and Cease-Fire are moving forward with their plans to take away our Second Amendment rights.

Legislation is being proposed next year in Washington by Cease-Fire and Greg Nickels that would require private collectors, private citizens and other non-dealers to conduct background checks before selling their guns "at gun shows or otherwise."

Already proposed at the Capitol is a ban on ownership on any .50-caliber firearm or cartridge in Washington State. In addition, these folks want to repeal our state "preemption laws." **If you hunt this is important to you.**

Without preemption laws, any local law would override state gun laws. You would not be able to travel 20 miles down the I-5 corridor without knowing if you are legally carrying or not – good luck getting to the mountains to hunt! Cities would be a patchwork of rules and regulations about gun ownership and carry.
